So much of Section V, AWARD OF BRONZE STAR MEDAL, General Orders Number 15, this Headquarters, 8 June 1944, as pertains to Lieutenant Colonel RICHARD J. CHAMIER, (0289829), General Staff Corps, Headquarters, 85th Infantry Division, United States Army, is rescinded; a Legion of Merit having been awarded by the Commanding General, Mediterranean Theater of Operations.

So much of Section IV, AWAPD OF BRONZE STAR MEDAL; General Orders Number 50, this Headquarters, 7 September 1944, as pertains to Technical Sergeant ELMER P. YELTON, (37202636), Infantry, Headquarters Company, First Battalion, 337th Infantry Regiment, United States Army, is rescinded; a Legion of Merit having been awarded by the Commanding General, Mediterranean Theater of Operations.

Section IV, General Orders Number 71, this Headquarters, 8 November 1944, pertaining to the award of an OAK LEAF CLUSTER TO BRONZE STAR MEDAL to Second Lieutenant JOSEPH P. LAMB, JR., (Oll78868), is rescinded.

### SECTION I

# AWARD, POSTHUMOUSLY, OF SILVER STAR

Under the provisions of AR 600-45, as amended, a Silver Star is awarded, posthumously, to the following officer:

NILS L. NILSON, (Ol306636), First Lieutenart, Infantry, Company "E", 337th Infantry Regiment, United States Army. For gallantry in action on 31 May 1944, in Italy. Lieutenant NILSON, a rifle platoon leader, courageously moved forward under intense enemy small arms and tank fire which had pinned down his platoon to attack a machine gun nest delivering heavy fire upon his troops. Moving into position within thirty yards of the enemy gun, he succeeded in killing its two man crew with a hand grenade and carbine fire. Then, leading the platoon in its continued advance through bitterly contested territory, he organized a ten man force to lead the attack on the flank of an enemy force which again delayed the advance from a group of farm buildings. In the ensuing skirmish, four of the enemy were killed and the remainder forced to withdraw, although Lieutenant NILSON himself fell mortally wounded. His gallant sacrifice of life to destroy the enemy force blocking the advance reflects the fine traditions of the military service. Entered the military service from Chicago, Illinois. 

Under the provisions of AR 600-45, as amended, a Bronze Star Medal is awarded, posthumously, to the following enlisted men:

ROBERT A. THACKER, (35430914), Staff Sergeant, Infantry, Company "F", 338th Infantry Regiment, United States Army. For heroic achievement in action on 23 October 1944, in Italy. At a time when his platoon was receiving heavy enemy artillery and mortar fire, Staff Sergeant THACKER, a mortar section leader, remained bravely in his exposed position to direct highly effective mortar fire upon the enemy infantry. Despite the intensity of the barrages, which threatened to cut him off from the platoon, he remained resolutely at his post although ordered to withdraw, continuing to give effective fire support to the forward troops and materially assisting them in their successful attack upon enemy positions. Entered the military service from Winfield, West Virginia. Next of kin: Mrs. Cora Lee Thacker, (Mother), RFD #1, Scott Depot, West Virginia.

JAMES G. PFEFFER, (35697716), Private First Class, Infantry, Company "M", 339th Infantry Regiment, United States army. For heroic achievement in action on 3 October 1944, in Italy. Discovering that his battalion's left flank was exposed and that the enemy was infiltrating to the rear in force, Private First Class PFEFFER took up the machine gun he was manning from a dug in position and advanced across exposed terrain under concentrated enemy machine gun fire to a position from which he could fire upon the hostile group. Setting up his weapon, he delivered such deadly and accurate fire upon the infiltrating force that he forced them to withdraw in confusion, leaving fourteen of their dead and wounded behind, eliminating a serious threat to the battalion flank. Entered the military service from Louisville, Kentucky. Next of kin: Mrs. Mary A. Pfeffer, (Mother), 534 W. Jefferson, Louisville, Kentucky.

IRVING BELDNER, (32659262), Private, Infantry, Company "A", 337th Infantry Regiment, United States Army. For heroic achievement in action on 26 October 1944, in Italy. Observing a wounded soldier lying exposed to enemy machine gun and rifle fire, Private BELDNER, a rifleman, bravely exposed himself to the enemy gunners in order to move over the exposed ground and carry the wounded man to safety. His unselfish action saved his comrade from further serious injury or death and enabled him to receive prompt medical treatment that saved his life. Entered the military service from Brooklyn, New York. Next of kin: Benjamin Beldner, (Father), 223 Beach 133rd Street, Rockaway Beach, New York.


